IMPLEMENTATION AND DEVELOPMENT OF ROTHERHAM MBC'S AIR QUALITY ACTION PLANS

The progress made on implementing the measures contained within the revised Rotherham Air Quality Action Plan –M1 (2006-2011) is listed below using the method recommended in LAQM.PRG(03), chapter 3.02.

The first Rotherham M1 Air Quality Action Plan was finalised in 2003, after a 2 year consultation process, taking account of measures within the first South Yorkshire Local Transport Plan (2001-2006). The Rotherham Air Quality Action Plan was fully revised during 2006 to reflect the Local Transport Planning process, proposed new developments, current guidance, air quality monitoring results and the second South Yorkshire Local Transport Plan (SYLTP2 2006-2011). The Rotherham Air Quality Action Plan (M1) 2006-2011 has been submitted to defra.

The Council declared four AQMAs for three major town centre routes during 2004. Further Assessment work found that the declaration was justified and initial work has been done on the formulation of an Action Plan for these routes which will be integrated into the South Yorkshire Local transport Plan (2006-2011) with the first LTP2 Annual Progress Report due in the summer of 2008. A prioritisation exercise was carried out during 2006-7 by Faber Maunsell on behalf of the South Yorkshire Authorities and South Yorkshire PTE to develop a programme of measures with the aim of improving air quality on the town centre routes.

Progress is detailed in the table below.
